

Emergency Preparedness Plan Hometown RV Park

The information contained in this customer Emergency Preparedness and Response Plan has been provided as a general guide to logical and safe steps to take in the event of an emergency at Hometown RV Park. This plan is intended to assist our guests in a possible emergency situation that may arise while visiting our park.

This plan will be posted on the notice board at the office and will also be provided to all guest upon request.

Safety is our number one priority. Please remember to act wisely and in all cases maintain your personal safety for you, your family, and guests while on site. For all emergencies, dial 911.

Please note, Hometown RV Park, Management, and Staff are not responsible for physically evacuating residents or guests from their onsite locations, nor are they responsible for providing any materials or services during an emergency.

Hometown RV Park Exit Plan:

In the case of a partial or full-park wide evacuation:

1. All campers and visitors will exit the area via the Main Entrance of Dwayne St.
2. If the emergency warrants it, a megaphone will be utilized to communicate instructions, inform/update nature of the emergency, and the appropriate response to make.
3. The Camp Host, Owners, or Support Staff are not responsible for removing either person or personal property out of the emergency area. The cooperation of everyone involved is greatly appreciated.

If emergency includes injury to an individual or multiple individuals or the possibility of injury, contact 911 IMMEDIATELY and then notify park staff.

Evacuation Route Plan Hometown RV Park

Written Description

Hometown RV Park is situated on the South side of the Yadkin River in the town of Jonesville, NC. Access to the park areas is through a two-lane roadway known as Dwayne Street. There is one main entrance to the facility.

The area in and around the park has been known to flood as the results of rising waters in the Yadkin River from excessive rainfall. Campground Management closely monitors the US Geological Survey Website as well as the NOAA Website for real time river levels and predictions. Guests will be notified by bullhorn if needed in the event water levels get to threatening heights.

Please do not block the roadway of Dwayne Street when entering or exiting the park. If Emergency Vehicles are incoming, please pull to side of the roadway and allow the vehicle(s) to pass.

It is assumed the sites located closest to the river #22, #32, #46 & #57 would evacuate first. The remaining sites would soon follow exiting in orderly fashion. However, in isolated emergency situations, such as a single RV fire, only the persons and RV's closest to the isolated emergency should evacuate to an alternate location within the park as designated by Campground Management, The Fire Chief, or Assistant Fire Chief on scene.

Please only use the designated roadway to evacuate the park.

In the event of the main evacuation route being blocked and the evidence of flood or rising waters, The River Trail may be utilized to exit the facility.
